## 4:07 ACM UPdates - Leslie Etheredge

- Splitting CWCOM into pre-authorization and post-authorization. Two branches, rather than three subcommittees
- Common complaint about the previous structure: folks aren't sure what they're supposed to be doing! But now, roles are clearly defined AND folks know who to ask if they happen to be confused.
- People didn't know what Annual Information Review was all about, so there's more to do for CWCOM in the future around communicating what's at stake with that
- Keep the intentions that we set around the creation of CWCOM. The goal of trainings is pastoral excellence. It's helping clergy show up as healthy as possible.

# 4:35 Discussion regarding a continuing ACM position

 There's no question that the ACM role is essential. The feedback sheet from CWCOM members indicates that Leslie's work is necessary and appreciated. We need an ACM for however many hours/for however long we can afford it. APPROVED BY CONSENSUS: Adding another 6-month offer to Leslie's position. Board
approves extending Leslie's contract, per her call agreement, by 6 months from the 2025
AC and revisit an additional 6-month extension at the end of 2025 to allow for COM to
stabilize and for us to assess the demands of the position. With that clarified, we will
post the position and conduct a national search.

## 4:55 TCM Updates - Erin

- Cultivating Generous Congregations course update: Unclear if we can get General funding for Andrew's visit. We will approach James Fouther and Melissa St. Clair to present something if Andrew can't make it.
- Takeaways from Erin's CCM gathering: Lots of conferences are realizing/have realized
  that conferences can't maintain both associations and COMs. Even the ones that can
  support both aren't doing it because it's redundant. Wisconsin Conference is moving
  toward a "resource hub" model rather than a geographical model. This affirms what we
  discussed in the last meeting: having representatives from associations on the board,
  and fostering connections across geography based on affinity and interest in mutual
  resourcing.
- Cornerstone Fund meeting: CF continuing to do good work! Meeting was almost comically ecumenical, a quintessential UCC day.
- CM transition timeline/tasks (with Laura) See <u>Circles</u> and <u>Proposed Transition Teams</u> docs: Laura and Erin have gone over job descriptions for other CMs from other Conferences. Thinking about how we can communicate the story and structure of the RMC to an outside candidate.
  - Game plan: Get listening teams together in April/May and have them visit every available church in the RMC. They ask questions: who is your church? What's your mission? What's happening for your community right now? The goal is to get to know what each congregation is involved with that brings life to their communities. This will help us understand what we need to support and staff, moving forward.
  - Discussed how to gain connection and information from churches instead/in addition to in-person visits, if needed.
  - This move helps us shift the definition of conference. Making it about the local churches, not the RMC structure.
